1. Participation:

Participation is open to anyone over the age of 18 at the time of participation, with a permanent residence and habitual abode in Europe. To participate in the competition, it is absolutely essential that all personal details provided are accurate and you only enter in your own name. Employees of Saalfelden Leogang Touristik GmbH, authorized representatives, legal successors and agents of the organizer and all companies, advertising agencies involved in organizing and running the competition, as well as their employees and partners, their families and household members are excluded from entering the competition. Tourism association Saalfelden is entitled to exclude participants who violate these conditions of participation or manipulate the competition.

2. Competition Procedure

The prize will be sent by email. The prize will not be paid out in cash. Multiple entries do not increase the chance of winning. Legal recourse is excluded.
